HETS obtains its data from the CMS beneficiary eligibility databases. The databases are considered the authoritative source for beneficiary Part B effective, termination, demographic, managed care organization, and end state renal disease (ESRD) data. Data in HETS is updated nightly with data from the Common Working File (CWF), a Medicare Claims processing system. The CWF contains data such as the Medicare Secondary Payer, Home Health, Hospice, Skilled Nursing Facility and hospital data.
